

# Assumption of Risk Policy

## (Ultimate Kids Camp)

At Ultimate Kids Ltd, we are committed to providing a safe and enjoyable environment for all participants attending our camps. However, it is important for parents and guardians to understand and acknowledge the inherent risks associated with physical activities, including but not limited to sports, exercise, and recreational games.

### **Acknowledgment of Risk**

By enrolling your child in Ultimate Kids Camp, you acknowledge and accept that participation in physical activities involves inherent risks, including but not limited to:

- Strains, sprains, and muscle injuries
- Bruises, cuts, and abrasions
- Falls and collisions with objects or other participants
- Fatigue and overexertion
- Accidents resulting from the use of equipment or facilities

These risks are not limited to specific sports or exercises but apply to all physical activities offered during the camp, including but not limited to team sports, individual fitness exercises, obstacle courses, and free play.

### **Assumption of Responsibility**

Parents and guardians acknowledge and agree that:

- Participation in Ultimate Kids Camp activities is voluntary and carries inherent risks.
- Ultimate Kids Ltd and its staff take reasonable precautions to ensure a safe environment; however, accidents and injuries may still occur.

- It is the responsibility of the parent/guardian to inform Ultimate Kids Ltd of any pre-existing medical conditions, injuries, or physical limitations that may affect their child's participation.
  - Parents and guardians should ensure that their child wears appropriate clothing and footwear suitable for physical activities.

### **Limitation of Liability**

Ultimate Kids Ltd, including its directors, employees, contractors, and affiliates, shall not be held liable for any injury, accident, or loss arising from participation in camp activities, except in cases of gross negligence or willful misconduct. By enrolling a child in the camp, parents and guardians agree to release and discharge Ultimate Kids Ltd from any and all claims, demands, and liabilities related to injuries or damages incurred during participation.

### **Emergency Medical Treatment**

In the event of an injury or medical emergency, Ultimate Kids Ltd will take reasonable steps to provide first aid assistance and seek further medical treatment if necessary. Parents and guardians consent to such treatment and acknowledge that any costs incurred will be their responsibility.

### **Code of Conduct**

To minimise risks and ensure a safe environment, all participants are expected to adhere to the camp's code of conduct, including listening to instructions, using equipment safely, and respecting fellow participants and staff. Ultimate Kids Ltd reserves the right to remove any participant who fails to comply with safety guidelines.

### **Agreement to Policy**

By enrolling your child in Ultimate Kids Camp, you confirm that you have read, understood, and agreed to this Assumption of Risk Policy. You acknowledge that participation involves inherent risks and that Ultimate Kids Ltd is not liable for any injuries or accidents, except in cases of gross negligence.
